CAMP PRIDE is a three-week day camp for young people 11 – 15 years old hosted by the Horry County Police Department and staffed by School Resource Officers. Camp is Monday through Friday from 8:00 AM to 4:00 PM. Slots for the camp are limited.

It is the mission of CAMP PRIDE to develop discipline, resourcefulness, and teamwork in each camper through a highly structured educational and adventurous camp experience. Campers will learn the principles of CAMP PRIDE through individual effort and role modeling. Parents will have the opportunity to help shape the camp experience for their child by expressing specific goals for individual camp objectives.

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND  
INDEMNITY, AND PARENTAL CONSENT AGREEMENT  
("AGREEMENT")**

In consideration of participating in **CAMP PRIDE**, I represent that I understand the nature of **CAMP PRIDE** and my minor child am qualified, in good health, and in proper physical condition to participate in such Activities. I acknowledge that if my minor child believe event conditions are unsafe, my minor child will immediately discontinue participation in the Activity.

I fully understand that **CAMP PRIDE** events involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages my minor child incur as a result of my minor child's participation in the Activity.

I hereby release, discharge, and covenant not to sue Horry County Police Department (*Camp Pride Day Camp*), its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, AND PARENTAL CONSENT AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extend allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect. In the event of an emergency, I authorize the Horry County Police Department and its officers, agents, servants and employees to secure from any licensed hospital, physician and/or medical personnel any treatment deemed necessary for my immediate care, and I agree that I will be responsible for payment of any and all medical services rendered. I am also giving permission to the Horry County Police Department and Camp Pride to allow the use of any photos and videos of my child for promotional purposes. This includes the Horry County Police Department and Camp Pride web pages and sites.
